Ad Valorem Division Road Trip 2006

The traditional road tour for the Ad Valorem Division is complete. This year we went from Tulsa (with OATR also) to Durant to Buffalo to Norman. That's a lot of miles, but as I've said many times in the past, it is really a pleasure to get to travel around Oklahoma and see what is going on in each county we visit. The only thing bad this year was I didn't win a single door prize. I was out of the room once and the other time, I was holding Larry Rawlings ticket.

Deborah Gibson, this year's President of the Oklahoma Association of Tax Representatives invited us to their spring meeting in Tulsa, and we always enjoy meeting with OATR. They have lots of experience and knowledge in the process.

Tulsa County did an outstanding job hosting the Northeast District at the Oklahoma Aquarium, a new Oklahoma destination there in Jenks. We enjoyed Ken Yazel's comments, his staff's hard work, and the presentation by the oldest surviving Buffalo Soldier that was really interesting and inspiring. Glendel Rushing, the "Dean" as the longest serving assessor, followed up with the Southeast District meeting in Durant. I was amazed at the growth in Durant, particular around the new Casino Resort area. Bryan County really went all out with good food and program from State Auditor and Inspector and Center for Local Government Technology (CLGT). We were honored to have Jeff McMahan attend the entire session and the key legislative leadership from Bryan County also joined the group at the meeting.

Unfortunately, I missed Harper County because I was at an IAAO meeting, but Kenny Chuculate reported that the session was good and well attended. Scotty Crosby did a lot of work in hosting the evening social and the program. Cleveland County did a good job hosting the last session. For some reason, they had quite a bit of the OU Sooner theme there in Norman. I was almost expecting Denise Heavner to have Barry Switzer at the luncheon. They had an excellent program with the Norman North Jazz group. I also thought that the Doug Warr monologue on his past life working in Cleveland County might be good enough for the "Last Comic Standing" TV reality show.

The Legislative session is over, but we haven't unraveled it. No one is sure entirely how everything will end up, but some significant ad valorem bills died in the last part of the session. Several new changes were made and we're still searching and evaluating those. Nothing major so far. We'll get everyone up to date on new legislation in a week or so.

We'll send out reminders on the abstract submission dates later this month. Abstracts are due on June 15. Statutes are strict on the deadline so please let us know. We'll be sending a bulletin reminder out shortly. The State Board of Equalization (SBOE) has scheduled June 19 (We said June 20 in the Ad Valorem Forum) for its regular meeting which should give everyone time to complete their abstracts.

Ralph Wilson, County Assessors Association President, and his officers and Legislative Committee members met with the Ad Valorem Division before the Bryan County meeting. As you may be aware, the Annual Conference planning is in progress. We'll be at the same hotel again and we should have a notice out on the room arrangements in a week or so. We discussed various plans

for the conference and had some good input from everyone involved in making the annual conference a good event.

Bob Behn, a lecturer at the JFK School of Government, wrote a recent column on improving management in government. He quoted President Andrew Jackson's thoughts on government jobs: "The duties....ought to be so plain and simple that men of intelligence may readily qualify themselves." In other words, he thought that almost anyone could do a *government* job. Jackson of course was interested in appointing lots of his friends and supporters to jobs so he didn't want a lot of training requirements, but as we all know in the ad valorem area, the work has become more complicated, not less. The job of the County Assessor has changed enormously in the last fifteen years. That's why our District Meetings, Annual Conference, the training provided by Oklahoma State, Ad Valorem Division, IAAO, and Center for Local Government Technology (CLGT) and Cooperative Extension are so important.

We enjoyed seeing everyone at the district meetings. Have a good month. We appreciate all you do for your taxpayers and all the hard work of county assessors and deputies every where. It's a tough job, but ad valorem is an extremely important part of local government in Oklahoma. We're all working to pass the system on better than it was given to us.

2006 Legislative Session Update

Dear Assessors,

I want to thank all of you who came to the capital and made phone calls to your legislators during the last week of session. We would not have defeated the oil & gas legislation without your help. I especially want to thank Gail & Wade for being there the last week of session. There were two out of the three of us there every day during that last week and it made the difference.

We still have the special session to deal with. We have a number of budget issues that are critical to county government. The exempt manufacturing and double homestead reimbursement fund much be funded.

It must be funded and delivered to the counties by June 30th for us to be able to use that money in the 2007 budget.

I have spoken with Jeff Spelman and they are trying to have everything prepared to get the money to us once the legislature makes the funds available.

Currently the reimbursement fund looks something like this:

Total exempt manufacturing claims: \$47,000,000.00 Double Homesteads: 2004 & 2005: 10,900,000.00

Total Funds needed: \$57,900,000.00

Current Balance of reimbursement Fund: \$19,000,000.00

Total Funds needed: \$38,900,000.00

There is supposed to be set aside \$19,500,000.00 for Education and \$18,500,000.00 for Counties. That leaves it short \$900,000.00.

We need to continue talking to our legislators about how important this funding is to us. You may want to tell your legislator exactly how much the State owes your county. For instance, the State owes Pittsburg \$ 5,229,128.43 for exempt manufacturing and double homesteads.

You can contact your legislative committee members for updates as well. Your legislative committee is Gail Hedgcoth, Ken Yazel, Debbie Collins, Wade Patterson, and I.
